When providing cross border services Mountain Leader must comply with national laws related to the provision of services.

When in this questionnaire we make reference to EU citizens or EU member states we are also including citizens coming from Switzerland and EFTA countries.

## Entry requirements for mountain leaders from EU member states - prior declaration or other

What are the requirements and documents which a mountain leader from EU member states has to submit for the purpose of a prior declaration?

- Copy of the IML diploma delivered in EU or ETFA countries or Switzerland
- Personal curriculum vitae (experience)
- Cover letter
- Medical certificate

- Copy of both sides of your nationality identify card
- Double-sided copies of your UIMLA card and/or your national association card
- Copy of your registration form/ document by the local or national authorities if appropriate
- Certificate of clean criminal record
- Proof of professional liability insurance which covers risks associated with activity as a mountain leader
- Certificate of knowledge of the French language is <u>not mandatory</u>; however, having one can be beneficial as it serves as an official proof of your language proficiency. Language certificates such as the DELF (Diplôme d'Études en Langue Française) or DALF (Diplôme Approfondi de Langue Française) can be obtained by taking exams conducted by the French Ministry of Education. These certificates are internationally recognized and can demonstrate your French language proficiency to potential clients and employers. In summary, while there is no specific language certificate required, having a good command of the French language is crucial for working as an "accompagnateur en moyenne montagne" in France. Being able to effectively communicate with clients and understand instructions is essential for providing a safe and enjoyable mountain guiding experience.

If the state does not regulate the activity, the provider must provide evidence that he or she has performed the activity in that state for at least one year during the ten years preceding the application. The service provider must be able to attest, on the one hand, that he/she is not subject in the country of origin to a ban, even temporary, on practicing the profession, and on the other hand, that he/she is not subject to a criminal conviction for one of the reasons which in France leads to an incapacity to practice the regulated profession of sports educator. Finally, and in order to allow a possible verification of his qualification, the provider must provide proof of his qualification.
